African-American History Self-Guided Tour

Visitors can pick up a flier at the Information Desk to take a self-guided museum tour highlighting important moments in African-American history. Featuring:

- A signed copy of the Emancipation Proclamation
- A signed copy of President Obama's 2008 "More Perfect Union" speech, delivered at the National Constitution Center
- A Deposition Notice for the Dred Scott case in the St. Louis Circuit Court, a decade before the controversial Supreme Court ruling
- A NAACP Press Release from 1951 announcing its decision to appeal the Topeka, Kansas, case in which a federal court upheld segregated school facilities
- A Broadside Calling for the Desegregation of the Armed Forces from 1943
- The American National Tree, featuring influential African-Americans including Paul Robeson, Fannie Lou Hamer, Ward Connerly and 2012 Liberty Medal winner Muhammad Ali
- Artifacts found on the site of the Center which give a glimpse into the daily lives of free African Americans in the 1700s
