## DAVID FIELD AND DREW KATZ JOIN NATIONAL CONSTITUTION CENTER BOARD OF TRUSTEES

Philadelphia (December 3, 2014) – The National Constitution Center has elected **David Field**, president and CEO, Entercom Communications Corp., and **Drew Katz**, CEO, Interstate Outdoor Advertising, and founder, The Drew A. Katz Foundation, to its Board of Trustees, which is chaired by Governor Jeb Bush. The new members were elected during the National Constitution Center’s October 21, 2014, board meeting.

**David Field** is President and CEO of Philadelphia-based Entercom Communications Corp., the country’s fourth-largest radio broadcasting company and a member of the New York Stock Exchange. Prior to becoming Entercom’s President in 1998, David served in a number of positions with the company, including Chief Operating Officer and Chief Financial Officer. Before joining Entercom, David was an investment banker at Goldman, Sachs & Co. in New York. David holds a B.A. in economics from Amherst College and an M.B.A. from the Wharton School of the University of Pennsylvania. David serves on the boards of Entercom, The National Association of Broadcasters, The Radio Advertising Bureau, and The Wilderness Society. He served as chairman of the Radio Board of the National Association of Broadcasters from 2005-2007. David is a former trustee of the Philadelphia Zoo and the Ad Council. David was named 2006 Radio Executive of the Year by *Radio Ink* magazine and was also named one of the Best CEOs in America by *Institutional Investor* magazine in 2006, 2007 and 2008.

**Drew Katz** is CEO of Interstate Outdoor Advertising, LP, headquartered in Cherry Hill, N.J., a position he had held for more than a decade. Drew is also a principal of Foster Interstate Media, Inc., a California-based company that specializes in digital signage, wallsapes, airport signage and stadium spectacular advertising displays. In 2003, he created The Drew A. Katz Foundation (formerly known as Infinite Possibilities Foundation) as a vehicle to lift the hopes and aspirations of those facing difficult life and health challenges, with a particular emphasis on children. Since its inception, the foundation has contributed more than \$2.5 million to more than 225 non-profit organizations. Drew is a board member of the International Board of Covenant House, the Outdoor Advertising Association of America, and Wilson’s Disease

Association International. He is a member of the Dean’s Advisory Council at Stanford Law School and a member of the Temple University Board of Trustees. He co-chairs the annual Garry Maddox – Drew Katz Celebrity Bowling Classic which benefits the Youth Golf and Academics program and The Drew A. Katz Foundation. He graduated from George Washington University and received his J.D. with distinction from Stanford Law School.
