NATIONAL CONSTITUTION CENTER EXTENDS SUBMISSION PERIOD FOR FINAL ROUND OF CIVIC LITERACY CONTESTS AWARDING \$175,000 TO THREE PHILADELPHIA SCHOOLS, INCREASING THE TOTAL NUMBER OF CONTEST WINNINGS TO NEARLY \$600,000

Philadelphia, PA (June 1, 2017) – The National Constitution Center will extend its deadline for public, charter, independent, and parochial school teachers in Philadelphia County to participate in the Center’s third and final round of Civic Literacy Contests.

The contest challenges middle and high school teachers and administrators to develop multi-year plans to improve constitutional literacy by engaging their schools with the National Constitution Center’s [Interactive Constitution](#). The best plans will earn cash prizes to implement the ideas in their schools and be shared nationally with schools across the country. Teachers and school administrators are asked to develop lesson plans, professional development opportunities, and teaching materials that will be used and support the Center’s *Interactive Constitution* within their classroom and school to enhance student learning. **The new submission deadline for the final Civic Literacy Contest is July 14, 2017.**

The three winning schools from the final round will receive cash prizes of \$100,000 for first place, \$50,000 for second place, and \$25,000 for third place.

The Center will host a series of workshops that will provide teachers and administrators with hands-on support in the development of their submissions. Only one application accepted per school. By September 2017, the National Constitution Center will have awarded nearly \$600,000 to schools in Philadelphia and students and teachers nationwide for their commitment to promoting constitutional education. From 2015-2017, the Civic Literacy Contests were made possible thanks to a multi-year, multi-project \$5.5 million grant awarded from the John Templeton Foundation.

Short Story Contests

The third and final round of the Coalition of Freedom Short Story Contest concluded in May 2017. 11th grade students at public, charter, independent, and parochial schools, as well as registered home school programs, were challenged to bring a moment in U.S. history to life by applying narrative writing skills while incorporating important concepts of our Founding Documents: the Declaration of Independence, Constitution, and Bill of Rights.

Essay and Playwriting Contests

Past National Constitution Center contests for students have also included the Founding Freedoms Essay and Playwriting Contests. The essay and playwriting contests invited 6th, 8th, and 12th grade students across the United States to submit an essay in response to a grade-specific prompt about our Founding Documents for the chance to win a cash prize. Twelfth grade students also had the option of writing a

play that, if chosen as the winning submission, would be performed live at the National Constitution Center by professional actors. The play prompt asked students to imagine how Mrs. Elizabeth Willing Powel, wife of Philadelphia’s mayor, would have responded to Benjamin Franklin’s comment, “A republic, if you can keep it,” when she asked him “Dr. Franklin, what have you given us?” on the day the Constitutional Convention concluded.
