#### **QUESTIONS TO CONSIDER**

- Slavery was embedded into America's fabric by the time of the ratification of the Constitution. Did this affect how long slavery lasted in America and how it ended?
- The 13th, 14th, and 15th Amendments ended slavery in America and tried to rebuild our nation on a stronger constitutional foundation. Did these amendments change the Constitution so much that it was like a re-birth—a "Second Founding"—of our nation?

#### **BIG IDEA**

Generations of Americans battled over slavery and the Constitution—with each side laying claim to the Constitution's text and history. These battles culminated in some of the biggest constitutional debates in American history (over the Constitution's meaning and its relation to slavery), important national compromises (like the Missouri Compromise), infamous Supreme Court decisions (like Dred Scott), pivotal historical events (like the rise of the Republican Party and the election of Abraham Lincoln), the bloodiest war in American history (the Civil War), powerful attacks on slavery (like Lincoln's Emancipation Proclamation), a decisive Union victory, and a series of transformational amendments to the U.S. Constitution—the 13th, 14th, and 15th—that brought the Constitution more in line with the Declaration of Independence's promise of freedom and equality.
